

**NEW HANOVER COUNTY  
JUVENILE DAY TREATMENT CENTER ADVISORY BOARD**

**Members:** 9 (5 at-large members and 4 representatives from each of the following agencies: Southeastern Center, New Hanover County Schools, NC Department of Juvenile Justice and Delinquency Prevention, and Department of Social Services)

**Terms:** Appointments are made for three years. Members may not serve more than two consecutive full terms and cannot be reappointed until at least one year after the last term. Initially, terms will be staggered with 1 one-year term, 2 two-year terms, and 3 three-year terms for at-large members.

**Purpose:** To develop necessary policies for the efficient and responsive operation of the Juvenile Day Treatment Center (JDTC), to advise the JDTC Director on programs and services to meet client needs; to help establish goals and objectives to achieve successful outcomes; to advise the County Manager and County Commissioners concerning the operating and capital needs of the JDTC; and to serve on relevant committees/sub-committees; and to actively promote public awareness of and advocate for the JDTC and its services. Established by the Board of Commissioners 12/6/2004.

**Qualifications:** Any County resident 18 years of age or older who has a sincere interest and commitment to promote positive youth development and to help youth succeed in their home community. Members shall be required to sign a Conflict of Interest agreement, which will be provided in advance of their appointment.

**Meetings:** Regular monthly meetings are held on the second Tuesday at 2:00 p.m. at the Juvenile Day Treatment Center.
