Number of Members: 12 plus 4 ex-officio members (County Commissioner, Chief of Medical Staff, Past Chief of Staff, and Chief of Staff Elect (non-voting))

Terms: Three years (effective September 1993); May serve up to a maximum of three consecutive terms (effective 8/13/07).

Regular Meetings: Fourth Tuesday, each month at 5:00 p.m. at the Medical Center. Committees of the Board average one meeting per month each. Trustees serve on committees as appointed by the Board's chairman.

Statute or cause creating Board: Charter or Articles of Incorporation issued by the Secretary of State, dated May 26, 1967.

Brief on Functions: Takes responsibility for the operation of a large public hospital through the establishment of policy and the deciding of major questions on finance, scope of services, facilities, future directions, etc., and through evaluating quality and costs.
